1. To review the minutes and action taken report on previous IQAC minutes
 - i. Action plan was taken from departments on parameters that needed improvement
 - ii. AQAR report 22 – 23 is submitted
 - iii. Successfully organised Smart India Hackathon 2023 Grand Finale, AICTE on 19th and 20th December 2023. Received positive feedback from the participants
 - iv. Prepared formats for Performance Based Appraisal System (PBAS) for Assistant Professors, Associate Professors and Professors for the academic year 2022-23.
 - v. IIQA was accepted. The process of SSR Documentation has started
 - vi. External academic and administration audit was conducted on 18th December 2023
 - vii. Purchased 2 new smart boards for class rooms in ECE Department and training is also given to faculty.
2. Academic Audit report of Departments
Discussion:
 - a. The placement percentage in all departments except CE is low compared to the same period in the previous academic year
 - b. The number of high packages in all the departments are very less
 - c. Students going to Higher studies is less in ME and MBA
 - d. EEE and IT departments have not signed any new MoU in the current Academic year
 - e. Heads of CE, ME, MBA are informed to plan the one week / two-week FDPs that are suitable to their disciplines
 - f. CE, ECE, EEE and IT Heads are informed to arrange guest lectures with academic resource persons
 - g. All the departments are asked to plan for organizing conference
 - h. Heads of CSE and IT are requested to send the students to Industrial visits
 - i. Heads of CE, CSE and EEE are suggested to improve the alumni activities
 - j. Departments of CE, IT, ME and MBA need to focus on journal publications
 - k. Patents are very low in all the departments
 - l. Faculty acting as resource persons is zero in departments of CSE, ECE, and ME

- m. Department heads of ECE and ME are advised to motivate the faculty concern to apply for R&D projects to various govt. and non govt. agencies
 - n. Consultancy amount is zero in Departments of CSE, ECE, IT and MBA
 - o. All the heads are advised to encourage the faculty to attend FDPs and workshops by utilizing financial support from the institution
 - p. Student participation in premier institutes is zero in CE, ECE, ME and MBA
 - q. Overall student participation in other institutions is very low in CE, ECE, EEE, IT and ME
 - r. Student NPTEL certifications are zero in CE department
 - s. Value added courses are zero in CE and IT
 - t. All the department heads have to concentrate on the student internships providing stipend
 - u. Student publications are very low in all the departments
 - v. Non-Government Scholarships in CE, CSE and IT are zero
 - w. Student enrollment Professional body member ships in zero in CE, and MBA
3. Percentage attainments of Bench marks against target
Discussion: Detailed report for each department on percentage of attainment of various parameters after second quarter is tabled.
4. Criteria in charges are collecting and consolidating data required for uploading in the SSR.
5. IQAC has advised the Head, FED to conduct the Prefinal Examinations to the first year students to familiarize them to the exam format.
6. In view of increased demand from the students it is proposed to increase the intake of CSE from 180 to 240 from the academic year 2024-25
7. It is proposed to organize SITAR 2024 and HoDs of CSE and IT are requested to co-ordinate the program.
8. All the heads are requested to collect Performance Based Appraisal System (PBAS) forms for academic year 2022-23 from their faculty and submit the assessment report
9. Non-teaching staff self-appraisal can be taken for academic year 2023-24
