Note: The approval for the additional course (s) / increase in intake / variation in intake is valid for two years from the date of issue of this letter for getting affiliation with respective university and fulfilling State Govt. requirements of admission.

The institution is required to submit a Joint FDR of Rs. 15 lakhs for the above sanctioned additional course of MBA by 31st August, 2008 to the concerned Regional Office.

The additional intake is being granted based on the projections shown in the Detailed Project Report regarding additional built-up space, faculty and other facilities for the proposed intake. It may be noted that all facilities including additional built-up area and appointment of faculty should be made available before the commencement of the next academic session. Random surprise inspections would be carried out to verify facilities and if the institution is found deficient in fulfillment of norms & standards of AICTE, appropriate action would be initiated by the Council.

The specific deficiencies for not granting the other proposed increase / variation in intake / additional courses to the institution are mentioned below:

1. Sr. level faculty (Ph.D Professor and A.P. Level) in cadre ratio as per AICTE norms not available in the course in which increase in intake/Additional Course/PG Courses is proposed.
2. Shortfall in Built-up area for the proposed courses.
3. Additional faculty identified for proposed increase in intake / additional courses is not as per AICTE norms.


You are hereby required to rectify the above-mentioned deficiencies and submit fresh proposal with all the relevant documents in support of the compliance of the deficiencies and requisite fee to the concerned Regional Office of AICTE for further necessary action.

All other terms and conditions in the letter referred above remain unchanged.
