In the letter under reference (1) cited above, the UGC, New Delhi has communicated the conferment of Extension of Autonomous status to "Prasad V Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, Andhra Pradesh" for a period of five years i.e. from the Academic year 2019-20 to 2023-2024, including ex-post-facto permission by UGC for the A.Y.2018-19.

In this connection, I am by direction, wish to endorse the orders of the UGC regarding conferment of Extension of Autonomous status to "Prasad V Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, Andhra Pradesh" from the Academic year 2019-20 to 2023-2024, including ex-post-facto permission by UGC for the A.Y. 2018-19, subject to fulfillment of the following conditions:-

- "Prasad V Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, Andhra Pradesh" shall continue its affiliation to JNTUK in future also at least till the recommended period of autonomy expires. The autonomy shall cease to exist on discontinuation of affiliation.
- The students presently enrolled in the "Prasad V Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, Andhra Pradesh" shall continue to be governed by the academic regulations of JNTUK Kakinada.
- The admission procedures to be followed by the "Prasad V Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, Andhra Pradesh" shall continue to remain the same as those of APSCHE/JNTUK for various programs run by it even after acquiring autonomous status.

- d. *The extension autonomous status for the "Prasad V Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, Andhra Pradesh" shall come into force with effect from the academic year 2019-20 to 2023-2024 and ex-post-facto permission by the UGC for the A.Y. 2018-19.*
- e. *The college shall follow the guidelines issued by the UGC in all matters.*
- f. *The college shall constitute the necessary Statutory Bodies and inform the University.*
- g. *There shall be no financial commitment on the part of JNTUK Kakinada and the college shall continue to pay all administrative/affiliation fees due to the University as usual.*
- h. *As by UGC the college may reapply for extension of autonomous status six months prior to the expiry of the autonomous cycle*
