16. Court cases if any with the Govt., AICTE etc.

1. College filed a writ petition in High Court of Judicature at Hyderabad for the State of Telangana and the State of Andhra Pradesh on 26th Day of December, 2014 to permit the college to collect a fee of Rs.80,000/- from each student as against AFRC, Govt. of A.P, APSCHE & Convenor, EAMCET

2. College also filed Writ petition (No.2708 of 2015) in the High Court of Judicature at Hyderabad for the State of Telangana and the State of Andhra Pradesh against JNTUK Kakinada (1st respondent) & Government of Andhra Pradesh 2nd (respondents) prayed that "this Hon'ble Court may be pleased to direct the 1st Respondent not to insisting on payment of Common Services Fee/Infrastructure Fee collected from the students admitted after grant of Autonomy status, pending disposal of the above Writ Petition and pass such other order or orders." Hon'be Court has issued interim order on 19.02.2015. Order: "There shall be interim direction to the first respondent not to insist for payment of common services fee/infrastructure fee until further orders".

The Governing Body noted the above details presented in Annexure XV page no.61.
